





# Presidential Action Needed on Advisory Committees Established by EO

- Under Federal Advisory Committee Act, all Advisory Committees created by the President (e.g. by Executive Order) must be renewed by the President every two years
- The MPA FAC was renewed by President Obama until September 30, 2017
